**ORDER FOR MONITORED EXCHANGE AT HELPING HANDS  
VISITATION CENTER OF DADE CITY**

After hearing evidence that established that the parties are currently unable to pick up and drop off their child/ren for visitation in a neutral manner, or at an agreeable location which is safe for the children physically and emotionally, the Court hereby orders the parties to use the Helping Hands Visitation Center of Dade City [hereinafter “the Visitation Center”], Monitored Exchange Program services for:

1. The parties shall schedule a monitored exchange intake appointment within ten (10) days by contacting the Visitation Center at (352) 388-1609.

2. The monitored exchange will take place bi-weekly, and will continue until further order of the Court, unless otherwise ordered. OR

3. The cost of this service is ten dollars (\$10.00) per exchange, which shall be paid by each parent prior to the exchange.

The failure to pay may result in the Court issuing a judgment against the responsible party. The parties shall follow the Rules and directives for the staff of the Visitation Center and law enforcement agency at the Visitation Center.

4. The parties shall notify the Visitation Center if they cannot keep a scheduled appointment. Failure to do so will result in the parties being required to pay for the appointment.
5. The Visitation Center and law enforcement personnel at the Visitation Center shall implement this Order by all lawful means to accomplish its purpose in providing safe and regular contact between the child/ren and parents. Reports of exchanges shall be submitted to the Court when requested by the Court or upon subpoena by a party. The Visitation Center may submit status reports to the court as needed or upon the request of the Court.
6. Either party may schedule a hearing before the undersigned Judge to review this Order and compliance with it.
