

New Policies for Judge Lewis' UMC Calendar:

- **As of January 1, 2017 Judge Lewis will ONLY hear division J4 and J8 cases on the UMC calendar. Effective July 1, 2017 Judge Lewis will no longer be hearing foreclosure cases.**
- Effective January 1, 2017 the UMC calendar will only have 25 slots allotted. Once those 25 slots are filled up no more cases can be set on the UMC calendar. You **MUST** call the JA at 352-521-4262 to reserve your slot for your case on the UMC calendar. You will just need to provide the date requested for your hearing, the case number, and type of motion. **Since there are only going to be 25 slots for the UMC calendar you MUST call before sending out a notice of hearing to make sure there is available time for that day.** The UMC calendar will still be a **first come first serve sign-up sheet**. So out of the 25 cases that are set with the JA whoever shows up to sign in that is what order the cases will be heard.
- Motions set on the UMC calendar are to be **10 minutes or less**. If it is more than 10 minutes the case will not be heard and need to be reset for a special set hearing. **NO EXCEPTIONS.**

UMC (Uniform Motion Calendar) Hearing Schedule and Procedures

Effective January 1, 2017 Judge Lewis is ONLY hearing division J4 AND J8 cases on the UMC calendar. Effective July 1, 2017 Judge Lewis will no longer be hearing foreclosure cases.

UNIFORM MOTION CALENDAR FOR FORECLOSURE CASES

Description:

Uniform Motion Calendar is for **short** hearings (**10 minutes or less**). There will only be 25 slots allotted for the UMC calendar every Wednesday. You must call the JA at 352-521-4262 to reserve your slot on the calendar. There will be a sign-up sheet posted and the cases will be heard in the order of the sign-up sheet. Due to the high volume of foreclosure cases, this UMC is intended to provide faster access to the Court for short matters if one party is willing to attend in person. Unfortunately, the Court **cannot** accommodate telephonic appearances if both sides want to appear by phone. Those will still have to be special set hearings coordinated with the judicial assistant.

Hearing Times:

Every Wednesday 12:00 p.m. – 1:00p.m. (**check website for cancellations**)

- Check website 2 days prior to hearing to confirm Court's availability.

Applicability:

- Hearings 10 minutes or less.

Procedures

- There will be a sign-up sheet posted outside of room 127.
- UMCs are handled on a first-come, first-served basis.
- There will only be 25 slots allotted for the UMC calendar.
- You must call the JA at 352-521-4262 to reserve a slot on the calendar.
- At least one side must appear in person. If one side wants to appear telephonically, must give written notice and toll-free direct telephone number to party who is appearing in person.
- Must coordinate if there is opposing counsel and give reasonable notice of hearing. Guideline: 7 days' notice will likely be reasonable.
- **Side appearing in person must bring:**

- **Copy of motion that is being heard**
- **Copy of Notice of Hearing**
- **Proposed orders and postage-paid addressed envelopes**
