MEMORANDUM

TO: All attorneys desiring appointment or reappointment for service to the Sixth Judicial Circuit Registry of Court Appointed Attorneys

SUBJECT: Solicitation for Court Appointed Attorneys in Pasco and Pinellas Counties

The Sixth Judicial Circuit is seeking attorneys to serve the Court-Appointed Attorney Registry, on all lists and in all geographic locations in Pasco and Pinellas Counties. Selection of attorneys is based on a completed application and résumé. Not all attorneys may be selected. The number of attorneys selected is based upon the Court's needs and may be adjusted to maintain proficiency of service to defendants.

**CURRENT COURT-APPOINTED ATTORNEYS MUST APPLY FOR REAPPOINTMENT.**

The Registry appointment is effective July 1, 2022. See Administrative Order 2022-016 for information regarding service lists, standards and qualifications, and case types on each service list. Please pay particular attention to the attachment of the AO as the case types on some service lists have changed.
